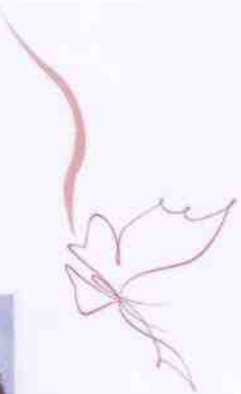

## Ideas for Year End Giving.



### Gifts of Cash: A specific Dollar Amount.

Cash gifts are deductible as an itemized deduction in the year you make the donation, up to 50% of your adjusted gross income. Excess charitable gifts can be carried over.

**Gifts of Real Estate:** If you own property that is not subject to a mortgage and has appreciated in value, a charitable gift may be an attractive option.

**Gifts of Life Insurance:** You can contribute a life insurance policy to us as either the owner or simply the beneficiary.

**Gifts of Securities:** The best stocks to donate are those that have increased in value with a low yield. In order to preserve tax advantages, it is critical that you give the securities to us rather than liquidate them and give us the proceeds.

**Percentage Bequest:** A certain percentage of your estate or of an asset.

**Restricted Bequest:** Gifts designated toward a particular program, such as Bereavement.

**Residuary Bequest:** A gift of assets which remain after your primary beneficiaries have received their benefits.
