

If you or your loved one...

- Needs short-term, in-patient care after leaving the hospital before returning home or temporary care to address pain and symptom management.
- Can no longer remain under hospital care, but needs skilled care that cannot be met in the home or another setting.
- Needs a residence if there is not sufficient family or support to manage the final days of life.
- Needs temporary respite care.



ADMISSIONS

- All admissions must be patients with Karen Ann Quinlan Hospice.
- Admissions are on a first come, first-served basis.
- Hospice Care is covered by the Medicare and Medicaid hospice benefits. Karen Ann Quinlan Hospice also works closely with private insurers to maximize hospice benefits, subject to applicable co-payments and deductibles. Private payment is also an option. Room and Board fees and charges are separate from the medical care benefit.
